PCUSA clergy (Revs.) are permitted to administer both sacraments provided the congregation's session has made provisions for the Lord's Supper or a Baptism to take place. Clergy of other denominations are generally NOT permitted to administer the sacraments.

PCUSA ruling elders are permitted to administer the sacrament of the Lord's Supper only with the permission of the Committee on Ministry. The elder wishing to administer communion should make that request to the co-moderators of the Committee on Ministry.

NO person shall serve in any vacant pulpit more than six times per quarter.

Any questions should be referred to the Committee on Ministry of Upper Ohio Valley Presbytery.
